

## Bauma 2024 COMPETITION Terms and Conditions

### Terms & Conditions

1. **Competition Overview:** This competition is organised by William Adams Pty Ltd ("the Promoter"). By participating, entrants agree to be bound by these terms and conditions.
2. **Eligibility and Exclusions:**
  - This competition is open to residents of Victoria and Tasmania aged 18 years or over and must hold a current and active ABN.
  - Employees of William Adams Pty Ltd, their immediate families, and any third parties directly associated with the competition are not eligible to enter.
  - Orders placed by William Adams employees on behalf of customers are not eligible for entry
  - Only the person associated with the registered account can place the order. Where a person is unable to be identified the order will be excluded.
  - Individuals or entities that offer similar products or services to those provided by William Adams Pty Ltd, including but not limited to their employees, representatives, or agents are excluded.
  - Customers who are actively engaged in competition with other attendees, either directly or indirectly, as determined by William Adams Pty Ltd in its sole discretion are excluded. William Adams Pty Ltd reserves the right to disqualify any participant it deems, in its sole discretion, to be in violation of these eligibility and exclusion criteria.
3. **How to Enter:**
  - To enter, customers must agree to purchase and sign a sales order and pay a machine deposit by 20/12/2024. The sale of the machine or placement of the order will be subject William Adams' standard *Conditions of Quotations and Sale* which can be found on William Adams' website. Final payment settlement of the machine and delivery to the customer must be completed by 31/01/2024.

    - **325** – Can be used with 1.99% Finance by Caterpillar Financial Australia Limited
    - **330 and 330GC** – Can be used with 1.99% Finance by Caterpillar Financial Australia Limited
    - **335** – Can be used with 1.99% Finance by Caterpillar Financial Australia Limited
  - Each machine purchase will automatically qualify the customer for one entry into the competition.
  - Multiple entries are allowed; multiple machine purchases (of the above models) qualifies for another entry.
4. **Competition Period:**
  - The competition opens on 18/11/2024 and closes at 5:00 PM on 20/12/2024.
    - Machine sales agreement and deposit must be paid by the 5:00 PM on 20/12/2024. Machines payment must be settled in full and be delivered by 31/01/2024.

**5. Prize Details:**

  - 2 Premium Economy flights return from Melbourne to Munich.

  - Trip Departs Melbourne on Saturday 5 April and arrives in Munich on Sunday 6 April for 7 days/ 6 nights, with a return to Melbourne on Saturday 12 April 2025.
